# RENTAL REQUIREMENTS

Please remember incomplete applications will not be processed. Past landlords and references will be contacted for rental history verification. Employment and income MUST be verifiable. Negative references, derogatory credit lines, collections, or unpaid judgments may keep an application from being approved.
